Aims & Objectives

Our primary aim at Bayis Sheli Young Adults Unit is to ensure the needs of the service-users are met and exceeded. The people that use our services have varying degrees of behaviours that challenge, learning disabilities and communication difficulties. We therefore ensure that they have an assessment plan, care plan, behaviour management plan, communication plan, health action plan and finally an ELP (if they choose to or if required). These plans are continually monitored and kept up to date. It is our aim to evidence that there has been progress in all areas of care and support offered to the individuals. We will work with young adults, of the Jewish faith, aged between 18 and 25, in establishing their goals for the future, and support them in identifying their prospective accommodation and support needs, be they physical, emotional or cultural. Bayis Sheli consistently aims to implement person centred learning approaches to their service delivery, (depending upon the individual's needs). It is anticipated that the people using our services will follow a lifelong learning programme. Therefore, we aim to empower the people we support, particularly with their independence and community skills, mirroring their cultural conducts. These, we believe, will enhance their personal growth and develop a deeper level of independence.

Bayis Sheli provides the people they support with a community-based programme. Many of our service users will have faced challenges in the community. Therefore, it is the aim of the service to ensure that everyone gets access to the community in whatever form this may be and for various levels of time. As an organisation, Bayis Sheli work with the local community so it can come to understand and empathise with the challenges our service users face on a daily basis. Bayis Sheli aims to ensure that the potential complex medical health needs of the individuals are met and managed to an excellent standard. This is managed by continual review of the individual's health and needs. These needs are also observed by their keyworker and management, in liaison with parents and the external professionals that are involved in the service such as OT/OH, SALT, DR, Community Nurse and Psych department (if required). Furthermore, we aim to ensure that at all times the people we support are safeguarded in all areas of their life. Therefore, staff will have a clear understanding of safeguarding matters and follow all local authority and national guidelines to ensure our service users are safeguarded at all times.

Bayis Sheli adopts from the onset a person-centred approach to its service delivery. This involves communicating effectively with those that live and use our services. This is implemented using various communication methods including PECS / TEECH / Makaton / objects of reference (based on individual needs). We will also aim to ensure that our service-users play a full and active role in the management and running of these methods in whatever format this is. We also actively seek to involve the parents and carers in the development of a service-user's home or service package. Bayis Sheli's management and staff team aim to be the most professional, knowledgeable, experienced, person centred and transparent team, one that respects and facilitates the religious lifestyle. The team of staff, led by the Manager, work in close conjunction to ensure that we are transparent in all areas of service delivery to the benefit of the service-users. The service and the team aim to meet and exceed the required minimum standards identified in the essential standards of quality and safety.

Description of Location:	<p>Bayis Sheli Young Adults Unit is a 6 bedroom unit located on the 1st floor of a 3 story, purpose built facility located in Stamford Hill, London. There are 6 bedrooms, 1 bedroom with en-suite bathroom and 5 bedrooms with shared en-suite facilities. Bathrooms include a range of facilities including a wet room shower, assisted and standard baths. All bedrooms are decorated and personalised to the individual. In addition, the unit has a dining area, living area and access to kitchen and laundry facilities. The residents also have access to a purpose built Hydrotherapy Pool, Multi-Sensory Room and Soft Play Area. A roof garden is located at the top of the building.</p> <p>In the surrounding area, residents have access to a wide range of activities, including education and leisure opportunities and shopping facilities located in the local community and further afield.</p> <p>The service accommodates service users with a range of needs, including those who may have; sensory disabilities, learning disabilities, autistic spectrum disorders, dual and/or complex multiple disabilities.</p>
